As the chart to the right shows, we expect to post strong full year 2019 results, especially regarding continuation of the strong position of our capital and replacement reserves. Our community's continued and increasing use of all the COA's numerous home maintenance services is contributing materially to our financial position.

Once again, I would like to thank all residents for their generous contributions to our employee holiday bonus fund. You made the holidays very special for so many of our employees.

Financial results as of November 2019

YTD Revenues - \$9,437,589

YTD Expenses - \$9,491,029 (includes \$1,762,136 in contribu-

tions to the capital and unrestricted funds)

YTD Net Loss - \$53,440 (net improvement of over \$6,000 from 3rd quarter)

The capital and unrestricted fund positions at the end of November 2019 totaled \$1,251,617 and the anticipated year end 2019 will be \$1,404,000.

Maintenance Update

I often get asked why the team is out mowing grass this time of year when it is not growing. What is really taking place is the vacuum mowers are collecting the leaves on the surface, as well as the ones stuck down in the thatch layer. It is extremely important to remove this debris allowing air movement around the individual turf plants. It keeps the leaves from adding large amounts of acid to your soil causing the pH levels to increase.

Another good tip is to start applying your pre-emerge herbicide now for summer weeds including crabgrass. Working with NC State professors, we know being really early far outweighs being too late. If you are interested in joining our turf program for 2020, please contact the office at 910-256-7604.

Many of you have probably already noticed winter projects taking place throughout the property. We are in the process of repairing and painting the Drysdale post office, as well as all the recreation buildings. We will be renovating the inside of the recreation restrooms as well.

Overlook Park is being replanted with new colorful plants

and the walking path is being repaired. Temple garden landscaping is being improved and refreshened. Other areas of improvements inlucde the pond roadsides on Radian Road, Quadrant Circle and Deepwood Drive.

Several projects are ongoing behind the scenes. Our whole building generator at 1749 Drysdale is installed and is ready to go if we experience any power failures. Miles of storm water ditches have been cleared and are open and ready for any future rain events. New eight foot wooden privacy fences are continuing to replace the old chainlink fence along Summer Rest walking trail.

There are many more small projects underway as we continue to keep Landfall looking fresh and desirable. One last thing I would like to point out is that we are in the final stages of replacing all our old wooden signs with our new aluminum design signs and posts.

I wish you all a continued safe and healthy winter season. I am always here if you need anything. If our wonderful team can help you out, please give us a call as we continue to keep your money working for you in Landfall.

Important Reminder

ARC Review of Home and Landscape Modifications by Brud Deas, ARC Chair

The Architectural Review Committee reviews all changes to home and landscape modifications including tree removals, play equipment, driveway modifications, etc. With each submittal, the Architectural Review Committee considers what is in place currently and what the property looks like now in conjunction with the changes the owner wants to make. The improvements (changes, additions or eliminations) must meet the current ARC Guidelines which are online at www.landfall.org/arc. Specific guidelines have been written for pools, accessory structures, fencing and the like. Accessory structures such as pool/guest houses and cabanas in which electric has been provided will serve as outdoor living areas and must be within the setbacks for the property and landscaped. The accessory structure should match the home

details and be coordinated with and compatible with the home in terms of materials. Landscape features such as gazebos, pergolas, play houses and fire pits must be located a minimum of 15' from any lot line and screened from the neighbors, golf course, street or common areas with substantial, taller evergreen landscaping.

For the landscaping modifications, these are welcome changes in Landfall because if there are large bushes that are mostly wood on the inside with a few leaves at the end of each branch obscuring the home, overgrowing the planting spaces and crowding the foundation, it may be time to renovate the landscaping. The landscape renovation should consider that for front foundation plants, two layers of evergreen shrubs plants should be planted with a taller plant behind and then staggered in front a shorter plant

that does not grow as tall. Smaller spaces could be left in the beds for perennials or annuals. A list of evergreen plants that do well in our area is included in the ARC Guidelines. Landscape bed plantings should include designs that provide for a plant of an upright growth habit with evergreen plantings interspersed in the beds around the upright growth. Leave enough room for the plants to be able to grow and not grow together unless a hedge is intended, and have room to get air and sunlight within the branches. As always, be aware of your property, easements, and the characteristics of your property that are listed in the covenants for your area, as well as the plat.

Updating your guest, service personnel and family lists are very helpful to our guards and help speed entry for your visitors. For those who come to your residence on a regular basis, adding them to your service list or perpetual guest list is a great way to ensure their access, without having to call them in each time. LANDFALL CERT SAFETY INITIATIVE

Your Community Emergency Response Team (CERT) has its focus on "neighbors helping neighbors". While we are trained for area wide disasters, CPR, and first aid responses, we additionally have assisted our community in searches for lost people, traffic control, and sponsor informational courses with an objective to make Landfall a safer place.

Late last year, Landfall CERT purchased an AED defibrillator for the Arboretum gate. While each patrol car has one, now there is one near the Arboretum postal station and for Drysdale postal station there is one in the CCL Sports Center. Signs have been installed with this information at both postal stations.

If you walk, bike, or jog in Landfall, your visibility could save you from a distracted (phone, text, food) driver. Landfall CERT has given out for free hi-viz, reflective vests to some residents. More vests are available at COA reception or in the security cars. PLEASE get one and wear it

whenever out on our streets.

CERT is partnering with Landfall security for safety reminders to help reduce the chances for injury in our community. Please take them to heart.

Your safety is in large measure up to you. Use common sense (light clothing, walking FACING traffic) and be wary of vehicles! There are many more distractions for drivers than ever before. Make 2020 indeed a happy and safe New Year!
