## UPDATE FROM THE LANDFALL COA CHAIRMAN By Gary Caison

In the last issue of the Voice, the Chairman's message focused on highlights and homeowner questions from the Annual Meeting. In this article we'll focus on providing additional action items taken relative to homeowner questions, provide updates on key projects, and close with some community reminders.

One of the resident suggestions at the Annual Meeting was that we consider placing reflectors on the roads to aid with driver visibility at night. The Board discussed and approved installing reflectors on Pembroke Jones Dr., Arboretum Dr., Deer Island Ln., and Odyssey Dr. The installation of these reflectors will begin this month. Suggestions about increasing the size and/or brightness of the street signs were also considered, but we are

making no changes at this time. Resident requests for off-leash dog space and improvements to the nature trail continue to be evaluated and we will provide more informative detail as studies are finalized.

The first key project update is a sidewalk study looking at the potential for adding sidewalks along our two most traveled roads: Pembroke Jones and Arboretum. For newer residents, the subject of sidewalks along these two roads has been discussed by multiple boards, multiple times, over the past 20 years. Our current study just entered its second year, following the last community-wide sidewalk survey. We have been involved with engineering firms, city and state agencies, legal counsel, bankers, and construction companies evaluating

best options and hurdles. It has been a huge undertaking to evaluate all of the factors at play and we have been very diligent in our efforts. We are close to finalizing the study and we anticipate sharing the results with the community within the next month.

The second project to discuss is the potential of bringing a fiber-optic network into Landfall. We believe that a premier community like ours should have a fiber-optic offering for current and future homeowners while retaining the current cable option for residents content with the status quo. We have been working with two companies: Spectrum and Cloudwyze to gauge their level of interest in this project.

This late April heavy frost has taken its toll on our warm season grasses. Many of them were coming out of dormancy extremely well until the frost hit. This unfortunately caused wide spread turf damage. Increased fertilizer rates and extra irrigation times on your turf should help tremendously in its recovery.

We are also seeing increased numbers in Nematode counts in our area soils. This is also causing increased turf death on many yards. If you are having any issues this spring you should reach out to your landscaper and ask for their assistance. If you do not have one our team of professionals would be happy to help.

On a more positive note the spring and summer flowers are all currently being installed throughout the property and should soon start showing wonderful colors.

Please let me remind everyone if you haven't purchased your brick for the Landfall Celebration Walkway it is a great way to honor, celebrate, remember or thank all those wonderful family and friends of yours. Also, let's not forget our furry friends as well. Just as important with Memorial Day just passed, how about honoring all of our heroes that have served this wonderful

Spectrum has withdrawn themselves from the process. AT&T has recently expressed an interest in the project. We are currently working with both AT&T and Cloudwyze and will keep the community updated as we move forward.

# Landfall Rentals and Lease Addendum Reminder

Please be reminded that Landfall's Rules and Regulations prohibit the rental of homes for less than six months with the exception of Prestwick and Colony Club, which require a minimum of a twelve month lease.

# Landfall Security Update By Chris Adam, Landfall Chief of Security

Summertime is steadily approaching and I just wanted to send out a few reminders about parking and fishing. First, overnight parking is prohibited on all Landfall roads. vacant lots and common areas other than designated parking areas. When attending events in Landfall that might require roadside parking, vehicles should be parked on the same side of the road as the other parked vehicles. All construction vehicles must park at the site. If there is insufficient space on the site, the parking of construction vehicles may be permitted on the construction side of the road pavement for short periods. In the event that other vehicles are already parked roadside, stay on the same side of the road as the other vehicles parked closest to the site. All roadways must provide one full lane of passage for residents, guests, and emergency vehicles. If you have special circumstances for parking, please contact me as I deal with these on a case by case basis.

Second, I would also like to remind our residents of Landfall's Rules and Regulations regarding fishing within Landfall. Any Personal Guest using the lakes, ponds, creeks and marshes must be accompanied by the host. Motorized boats, boating and swimming are prohibited in these areas. Fishing in Landfall's COA retention ponds and lakes is for recreational purposes only. All fish caught must be released back into the retention pond or lake. Catch and release fishing is prohibited from the following areas: street paving, bulkheads and bridges. Parking is not permitted on or adjacent to the road rights of way for fishing.



In the spirit of putting a name with a face, I am planning to highlight a member of your Landfall Security staff in each issue of the Landfall Voice. The first two officers I would like to introduce you to, I also want to honor; Sandra Moore and Ivan Rossinskiy. Sandra is one of the dayshift Sergeants and has worked for Landfall for 19 years. She comes from a fire service background, and in her free time loves doing crafts. Ivan is one of the dayshift Corporals and has been a member of the Security team for 12 years. Ivan came to us from Kyiv, Ukraine where he worked in the Embassy. Ivan became a US citizen 5 years ago along with his mother.

On April 19, Sandra and Ivan responded to an assist EMS call where a Landfall resident was unresponsive. Upon arrival at the residence, Sandra started CPR while Ivan set up the AED (Defibrillator). Ivan gave the resident a single shock just prior to Wilmington Fire Department (WFD) personnel arriving. WFD responders were able to then get a pulse before transporting. When I spoke with the WFD Captain, he said that because of the efforts of Sandra and Ivan, the resident had a fighting chance. Just a short time ago that resident was able to shake Ivan's hand and thanked them both for what they did. Great work team!

# Summer Fun and Architectural Review

With summer quickly approaching many homeowners are focusing on outdoor living spaces adding features such as stone fire pits, pergolas, outdoor kitchens, cabanas, swimming pools and pool houses to name a few. The design process, including landscaping, is critical to ensure that walls, patios, pool decks, firepits, etc are an integrated part of the entire site development scheme. When planning it may be easier to imagine your yard / garden as several different "rooms" in the same way you compartmentalize your interior space.

Accessory structures such as pool houses, cabanas, or pergolas should incorporate design elements and materials consistent with the primary building. The structures must be located within the established Landfall setbacks. It should be noted that Landfall's setbacks are more restrictive than City setbacks. The property plat and covenants should be consulted to insure the design meets the applicable requirements. Email arc@ landfall.org to request a complete list of applicable Landfall documents.

You may want part of your outdoor

living space to be more private than another area. Shrubs or dwarf trees are an easy way to accomplish that goal or a planted trellis with vines is another good screening option. Pathways, stone steps and terraces using natural materials are encouraged. The design objective is that the outdoor living area will blend the project into a natural setting. All project elements, including the landscape design, must be consistent with the ARC guidelines.

In order for the ARC to review your plans, the committee needs to know the structure location in relation to the existing site features, the design and materials that will be used. Therefore, the ARC will need the following for a review of your outdoor living features:

 Modification to existing home form available online at www.landfall.org with a description of the project and scope of work.

• A 1"X10' scale site plan showing the home foundation, lot lines, setbacks, spot elevations for existing/finish grade, current landscaping and hardscape features, platted easements (if any), and proposed hardscape and landscape improvements.

 Dimensioned elevation drawings with materials labeled. These drawings should be submitted at ¼" scale and include dimensions for all components of the feature.

 Material and color samples along with a complete list of all materials to be used.

• The landscape plan must label the location of new landscaping with leader lines to the plant names. Include a plant list which indicates species of plant, quantity as well as height and width at installation and gallon size. Include existing and surrounding landscape plants.

Interactive ARC Guidelines are available online at www.landfall.org. The Guidelines contain detailed sections for pools, fences, pool houses, and landscape requirements. The Guidelines should be consulted prior to working with a design professional. The deadline for submittals is the 1st and 3rd Mondays of each month by noon. The program pairs hospital and clinic patients with canine volunteers and their owners.

Christina, who is a retired intensive-care nurse, knows well the needs of patients who can feel alone and scared in hospital and treatment environments, and she wanted to do something to be of service. Her sweet Buddy actually arrived to her family over two years ago when her husband was quite ill with Covid, and the tending doctor's cousin had a new litter of French Bulldog pups. It seems



Buddy was born to be a therapy dog!

Buddy was trained in a sixweek class at Four Paws and a Wake-Up NC Canine Services, and is registered with the AKC for his service approval. He was taught to not be afraid of wheelchairs, to pass food and not eat it, and to be friendly with patients. Christina and Buddy visit several different Novant hospital wards and

clinics, including the Zimmer Cancer Institute, the pediatric clinic, the Rehabilitation Center, and the Orthopedic Clinic, twice per week. Christina said that Buddy really loves kids so much, and will lick their hands and feet, while the young children will take a stethoscope to Buddy to "check him out." Parents in the children's ward are grateful for the distraction that

Buddy and Christina provide.

In addition to Christina's amazing service to Novant, she is an active member of the Landfall Country Club and is in the Nine-Hole Golf League, and is on the Board of Directors and is Historian for the Great Oaks Club in Landfall. Additionally, she is in a knitting club and a book club, and recently became a first-time grandmother to baby Oliver, 11 months; and Mila, six months. She loves to cook (especially Swedish meatballs and cinnamon buns!), and loves to travel. She and her husband expect to hit Denmark, Sweden, Budapest, and Prague before the year is over!

The April 2023 financial statements have been approved by the Board of Directors. Financial results as of April 2023 are as follows:

YTD Net Income	\$195 <b>,</b> 000

The Capital Improvement Fund (CIF) ended April 2023 at \$3,719,000 and is estimated to end the year 2023 at \$3,063,000.

The 2022 Audit has been completed and accepted by the Board of Directors. There were no required changes to the year-end financial statements that were presented at the Annual Meeting on March 30, 2023. This 2022 Audit Report will soon be made available on the resident portal of the Landfall COA website.
