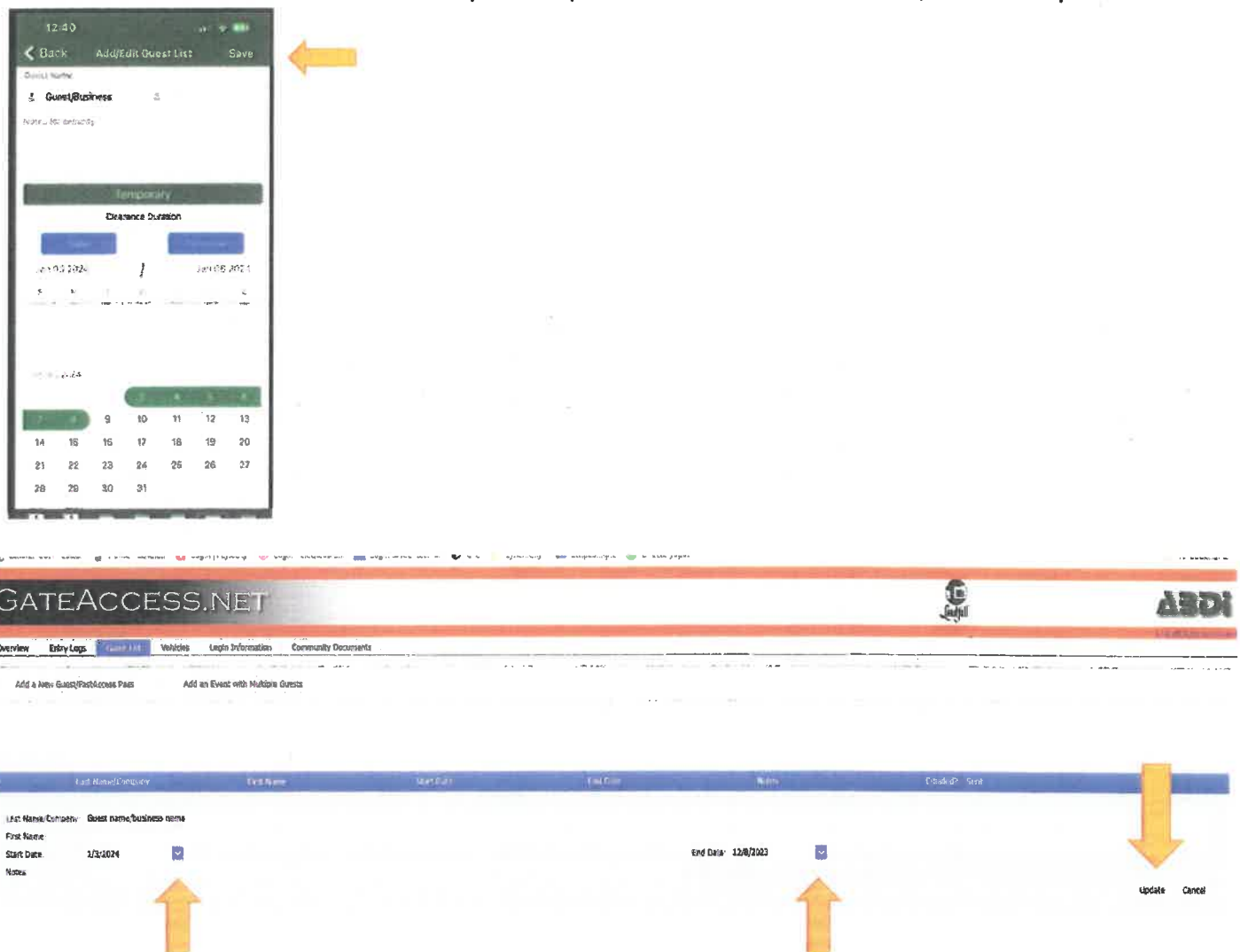
On the app click Add Guest, on the website click Add a New Guest/FastAccess Pass.



Enter either the business name or the name of the person coming in under Guest Name.



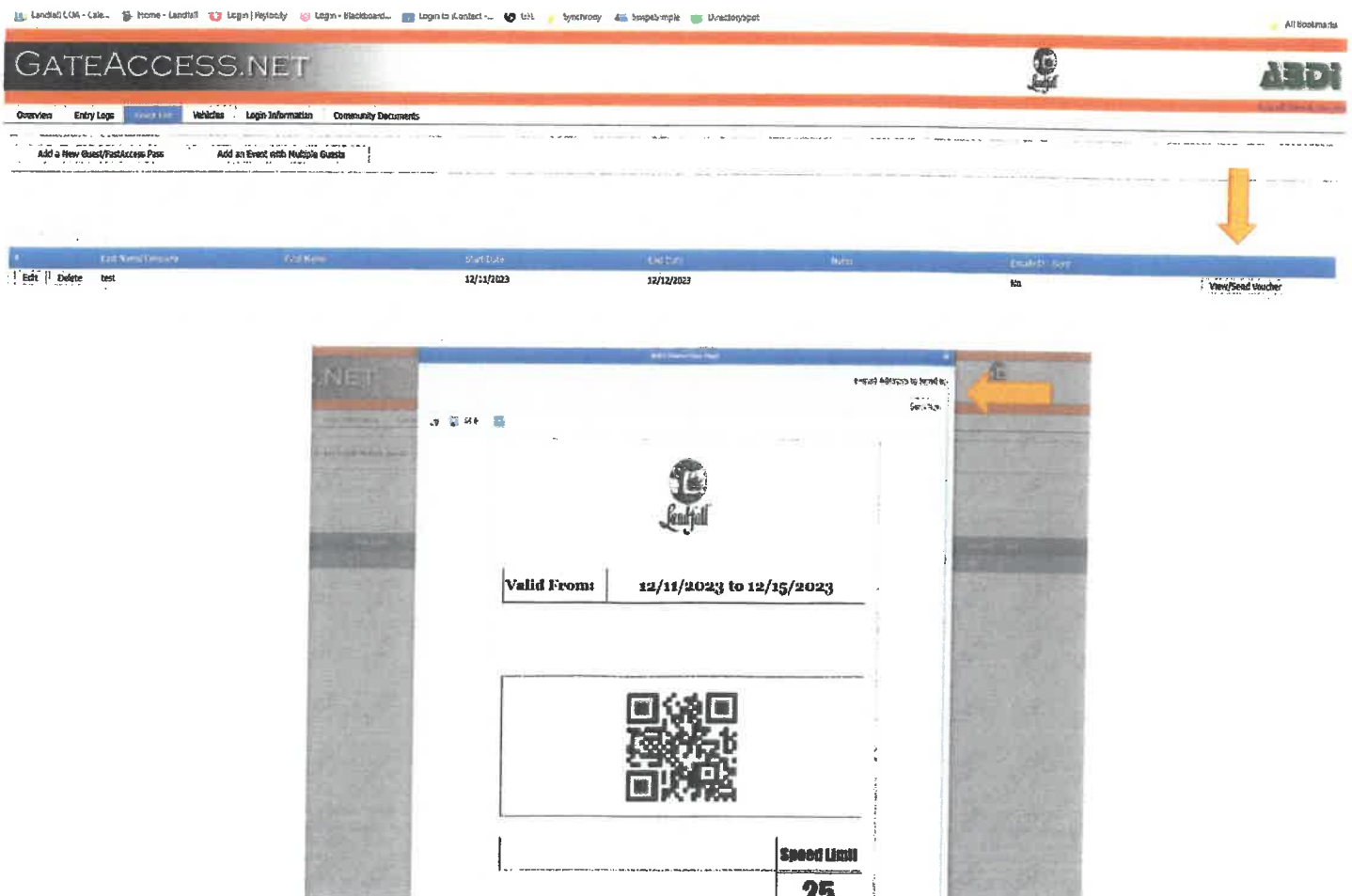
Select the duration of the visit. Guests may be added for 1 day or up to 1 year. On the app you can tap today, tomorrow or tap the start date and scroll, then tap on the end date. The span will turn green. Click Save. On the website use the drop down option to select start and end date, then click Update.



The app will ask if you want to send a Quick Access Pass. You DO NOT have to send a pass for them to get in. If you chose to send one, it will be good for the length of visit.

## COUNCIL OF ASSOCIATIONS MISSION STATEMENT

The mission of the Landfall Council of Associations (COA) is to promote the safety and welfare of the residents and provide for a high quality of life within the Landfall Community. The COA will coordinate functions of the owners' associations within Landfall and provide for the maintenance, preservation and control of the shared common areas.

This will be accomplished by providing leadership through the governance structure as detailed in the Master Cross Access Easement and Maintenance Agreement. Homeowner associations have delegated certain powers and authority to the COA to coordinate the maintenance, preservation and control of the shared common areas within Landfall.

The COA will maintain the community's appearance, infrastructure, security, and financial health, and enforce appropriate standards in order to sustain the beauty, character and architectural integrity of our community.

The COA will continue to foster and encourage positive relationships within the greater Wilmington community.





## THE ARCHITECTURAL REVIEW COMMITTEE AT A GLANCE

**If you plan to make any modifications to your home or landscaping (including tree removal on vacant lots), all alterations must be submitted in writing to the Architectural Review Committee for approval prior to construction or installation.**

### **Home or Landscape Modifications:**

All additions, subtractions or modifications to property must be submitted to the Architectural Review Committee (ARC), including but not limited to play equipment (trampolines, swing sets and basketball backboards), landscaping, generators, pools and fencing. Most submittals for modifications to property (other than new homes) can be done with the following:

1. Modification to Existing Home and Landscape Form available online at [www.landfall.org/arc](http://www.landfall.org/arc), as well as in the Guidelines.
2. A site plan showing the lot lines, home footprint and the location of the additions or modifications. For fences or home additions, the site plan should be printed at 1"X10' scale.
3. A photo, drawing or brochure of the proposed addition dimensioned with materials labeled.
4. A list of materials, colors and sizes of modifications, as well as, color/material samples. Landscape revisions must include the site plan showing the location of the plants and a plant list which indicates the species of plant, quantity and height/width at installation.
5. ARC fees and impacts fees apply for home modifications requiring elevation drawings, increase in square footage or pool additions. A deposit is required for fences and generators.

### **New home construction:**

Once a property owner has purchased a lot or is under contract, the property owner is now eligible to begin the process of submitting home plans to the ARC for review, comment and approvals. Three submittals are necessary so please allow a minimum of 2 to 2 ½ months for final approval and construction start. Final approval is to be received in writing prior to any clearing, grading or construction. Final approval to begin construction will also be in writing.

### **Meetings and Deadlines:**

The ARC deadlines for submittals are the 1st and 3rd Mondays of each month by noon. The ARC meets the 2nd and 4th Mondays of each month. Landscape renovations and tree removals are reviewed as needed to accommodate the volume of submittals.

## **LANDFALL COA ACCOUNTING DEPARTMENT INFORMATION FOR PROPERTY OWNERS**

Welcome to Landfall!

Landfall is known for its beautifully maintained and landscaped vistas. Flowers, trees, shrubs and lovely landscaping provide a serene, inviting atmosphere. Security personnel work twenty-four hours a day to patrol the property and contribute to the safety of its residents. The Landfall Council of Associations (COA) is responsible for the ongoing maintenance and security of Landfall. The COA collects assessments to cover the costs of security and of the maintenance of the common areas.

We hope the following information will help clarify the process of paying your assessments.

Landfall COA assessments are payable twice a year. Invoices are mailed no later than December 1<sup>st</sup> and June 1<sup>st</sup>. Payments are due on January 1<sup>st</sup> and July 1<sup>st</sup> each year. There is a 30-day grace period for payments. After 30 days, a 10% late fee will be charged. In addition finance charges will be applied on unpaid assessments.

When remitting payment of assessments, please notate the Landfall property address on your check and include the top portion of the invoice with your payment. The property address serves as your “account number” which will speed up the processing of your payment as well as ensure that the payment is posted to the correct account. Please note that Landfall COA is a completely separate entity from the Country Club of Landfall (CCL). We cannot process your payment if a check is written to include both CCL dues and COA assessments.

There are separate homeowners associations within Landfall and all of these are completely separate entities. Invoices for these assessments will always be sent separately and should be paid to the homeowners association directly. A list of the homeowners associations within Landfall and contact information for their respective Board Presidents is provided in this packet for your reference.

In addition to accepting payments with checks or cash, credit and debit card payments are accepted to pay for your Landfall COA semi-annual assessments, maintenance services, security citations, etc. Simply call the COA accounting department at (910) 256-7651 or email [accounting@landfall.org](mailto:accounting@landfall.org) and request a payment link. Additionally, the payment link has been added to the resident portal of the Landfall COA website under the document library tab and is labeled “Credit/Debit Card Payment Link”.

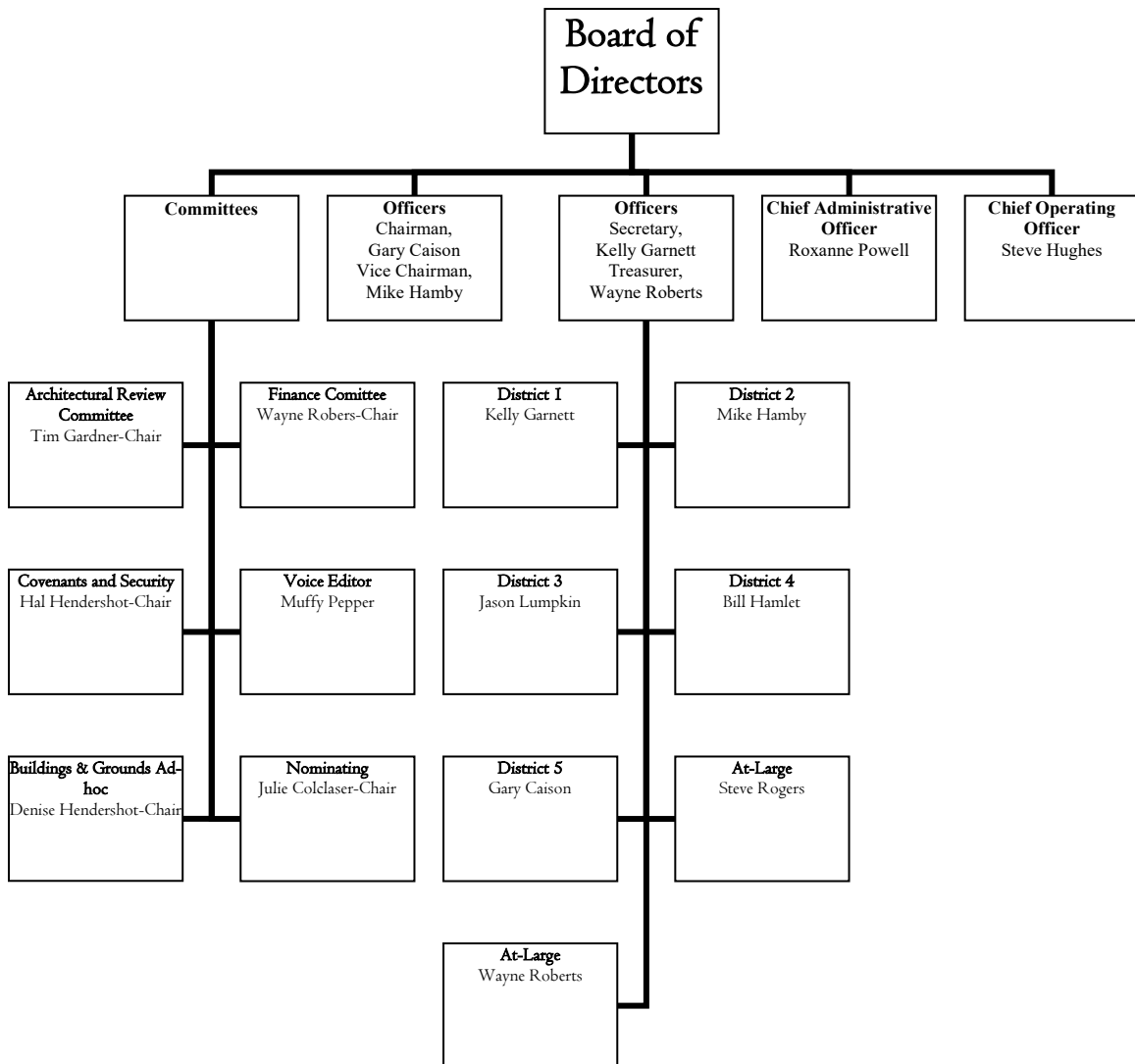
In order to offset the costs of credit/debit card processing, payments made through the payment link or taken over the phone will incur a 3.5% convenience fee. Please be aware that this is only for Landfall COA invoices and not for individual association charges. Payments for individual association assessments and charges should be paid via check or cash and forwarded to the appropriate remittance address.

If your billing address should change, please notify the accounting department in writing. Our mailing address is 1749 Drysdale Drive, Wilmington, NC 28405. Notices to the CCL about address changes will not be forwarded to the COA.

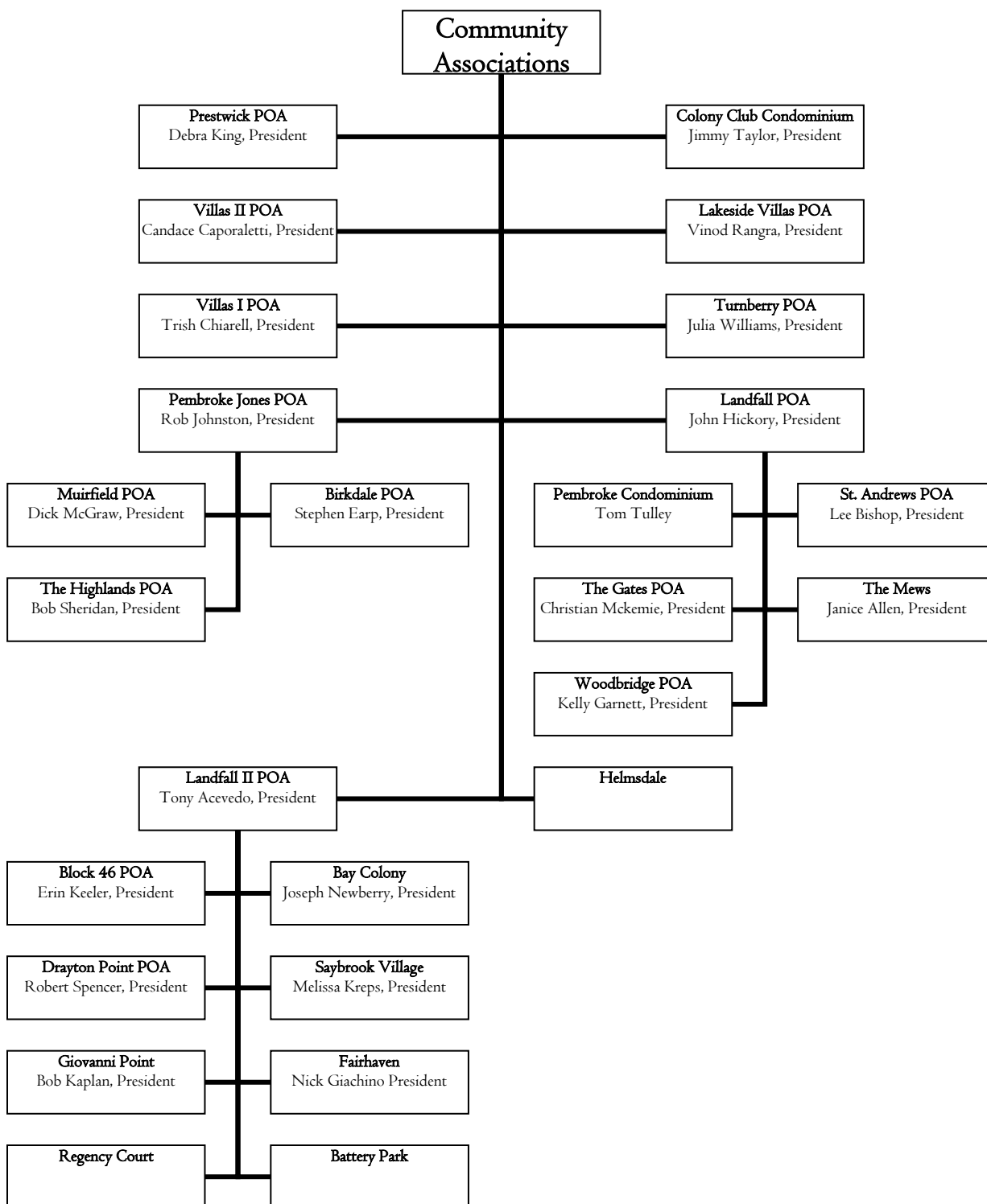
# Landfall COA Organizational Chart

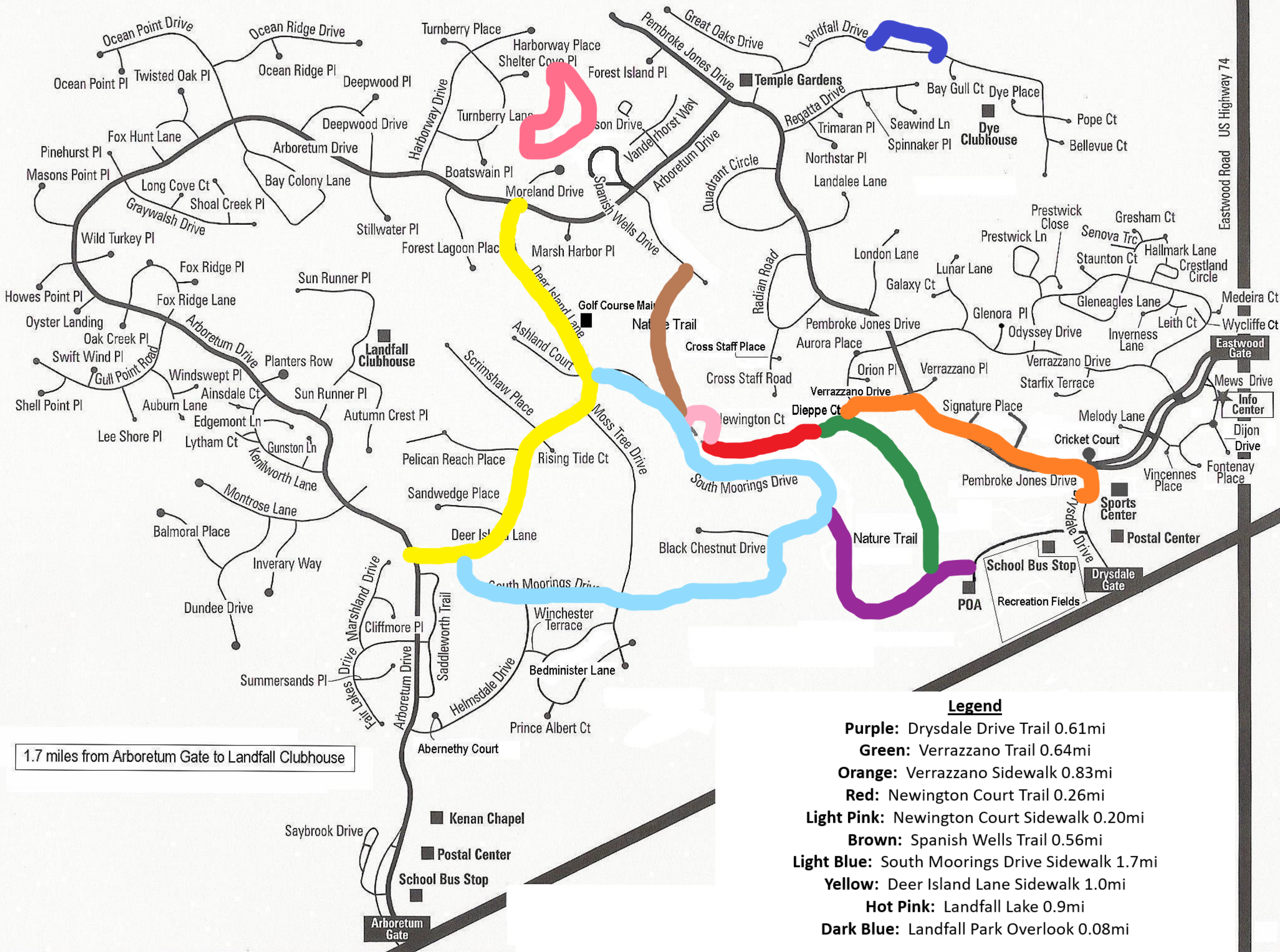
# Community Association Organizational Chart

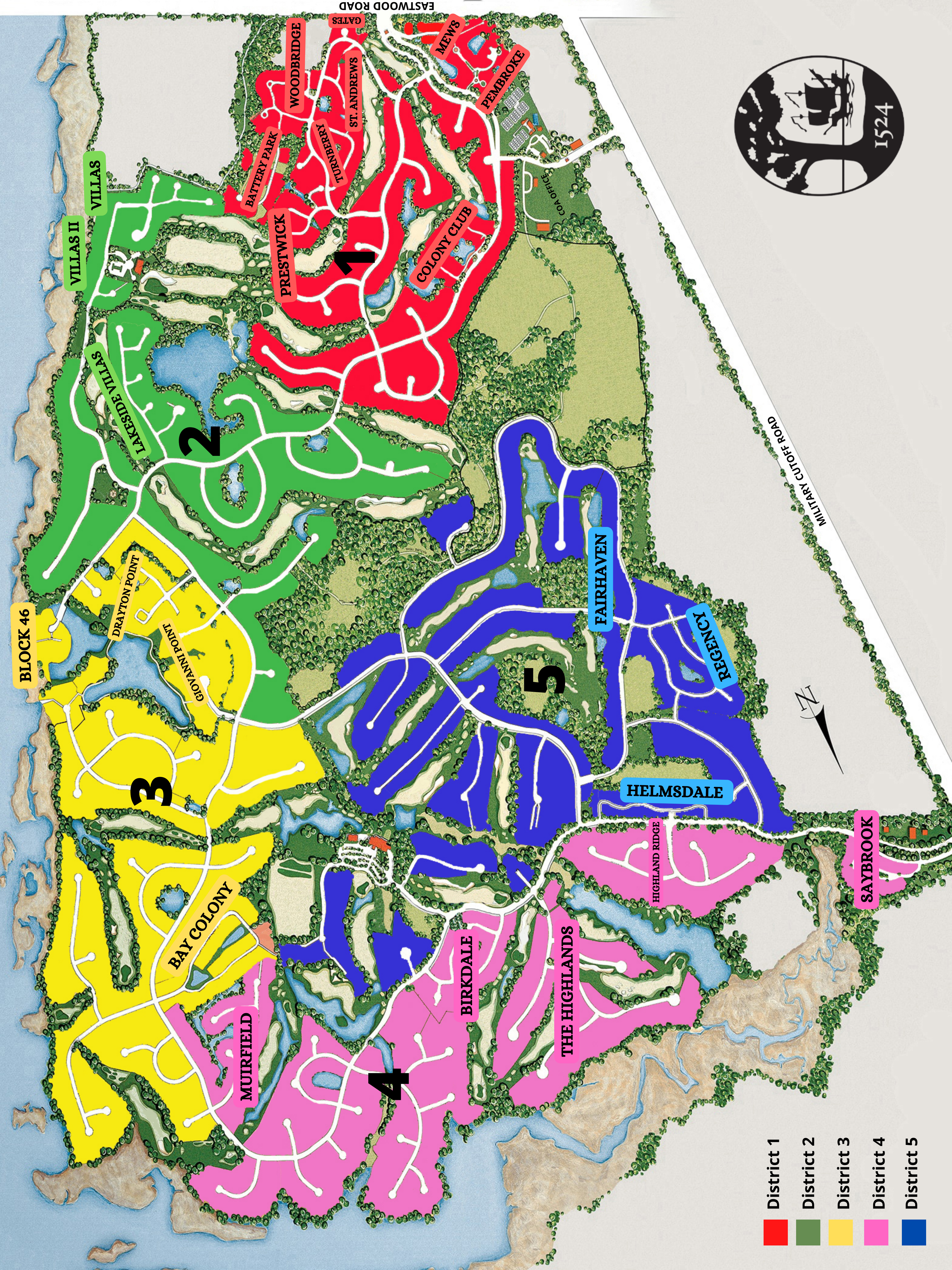








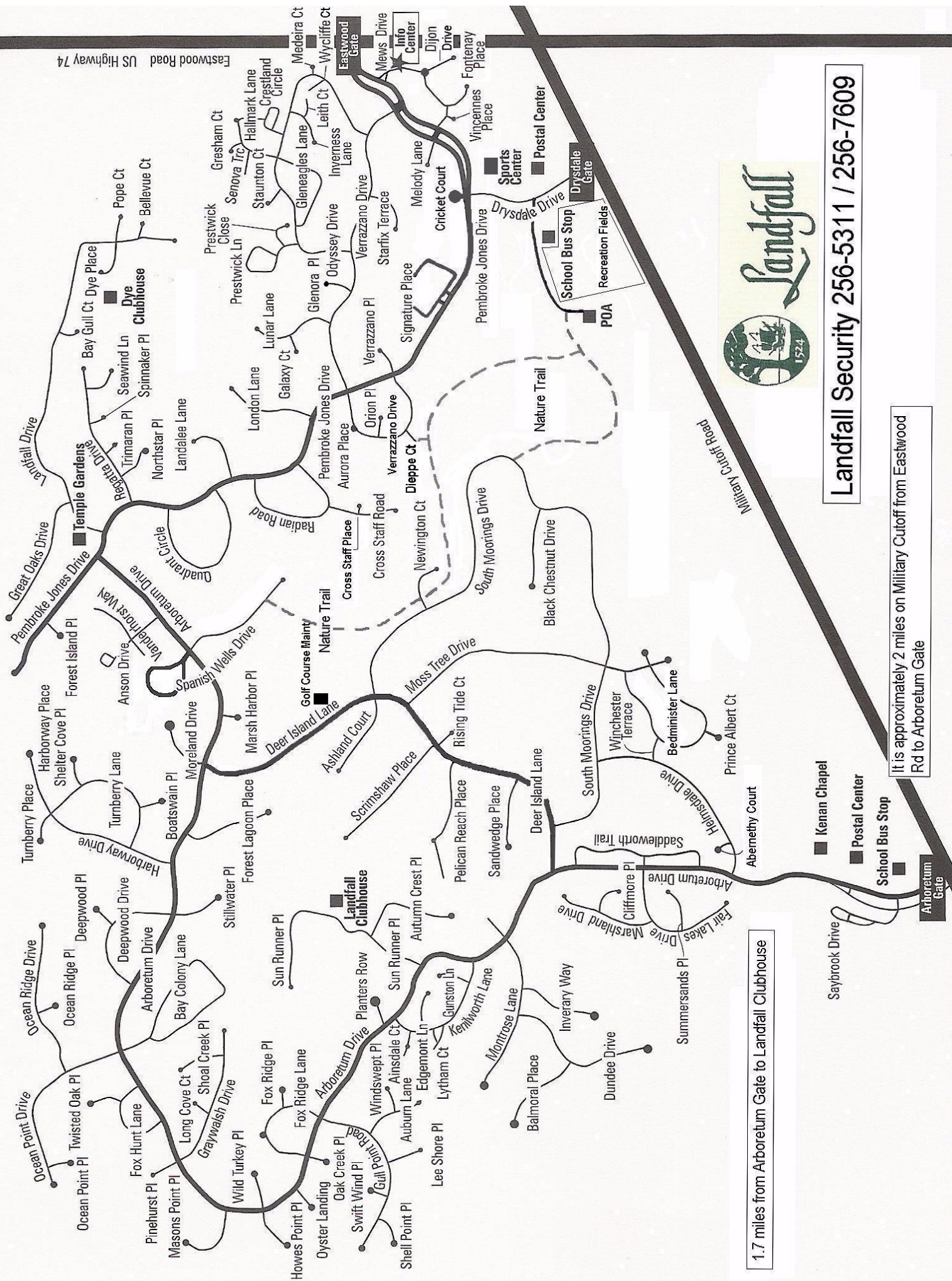

## **LANDFALL POST OFFICE GUIDELINES**

Use your Landfall street address **not** your box number.

Please introduce yourself to the postal carrier upon your first visit to the Postal Station to let them know that you expect to start receiving mail at your new box.

A carrier is usually available weekdays from 12pm – 5pm and on Saturday from 1pm until 3pm.

If you are planning to be away temporarily, please let the carrier know by leaving a note in your mailbox telling him/her when you plan to return and giving any special instructions (or complete a USPS Form 3575 available upon request from the carrier). Your mail can be held at the Arboretum or Drysdale Drive Postal Station for up to 30 days. In addition, your mail can be held at the Dogwood Station Post Office located at 314 Lennon Drive upon request. You can call the Dogwood Station Post Office for more information at (910) 313-3273.

Parcels too large to fit into your mailbox, that do **not** require a signature, will be put in a parcel locker located at the rear of the building. A key/ring with a number on it will be placed in your mailbox. Simply match the number on the key/ring with the number on the parcel locker, insert the key & remove your parcel.

## **AREA SERVICES**

**REGISTER TO VOTE** To be eligible to register to vote, you must be a legal resident of the state county, and prior to voting in an election, must have resided at your residential address for at least 30 days prior to the date of the election. Likewise, you must be at least 18 years old or will be 18 by the date of the next general election. Register to vote at the following location: Board of Elections Office, 1241A Military Cutoff Road, Wilmington, NC. **DRIVER'S LICENSE** Newcomers must obtain a driver license within 60 days of establishing a permanent residence. To obtain a NC REAL ID driver license, newcomers should bring:

- A. Their out-of-state license,
- B. 1 form of identity such as a Birth Certificate, a valid, unexpired REAL ID driver license, or valid unexpired US Passport,
- C. 1 proof of Social Security number or ITN (Individual Tax Payer Number),
- D. 2 forms of proof of residency, (NCREALID.gov for details of accepted forms of identification) and
- E. Proof of liability insurance

to a North Carolina Division of Motor Vehicles (NCDMV) testing station, where they must pass a road sign recognition and vision test. (Effective May 2014, written test is no longer required if you hold a current driver's license from another state).

*If your name has changed*, 1 document with proof of name change: such as a Certified marriage license/certificate, Certified divorce decree, or see NCREALID.gov for details of other accepted forms of identification.

*All first-time applicants* for driver licenses, learner's permits and ID cards must provide proof of residency, and proof of age and identity. *All applicants* must provide proof of their full name, age, and their Social Security number. See the DMV website, NCREALID.gov for details of accepted forms of identification. Road tests are given at the examiner's discretion. The NCDMV accepts cash, personal checks may be accepted if drawn from a local North Carolina bank, and money orders, as well as Visa, MasterCard, American Express and Discover credit and debit cards. If you are under the age of 65 and older than 21, your license is valid for up to 8 years. When you pass your 65<sup>th</sup> birthday, your license will expire every 5 years and you will be unable to renew online. *All minor applicants* under the age of 18 years old must have a "drivers eligibility certificate", high school diploma or its equivalent, or other forms listed on NCREALID.gov to be eligible for a NC driving permit or license. **INSPECTIONS** For new residents moving from out-of-state have 10 days after getting their NC auto tag to have their vehicle inspected and the inspection sticker displayed on their vehicle. ## **PARKS**

### **LONG LEAF PARK**

Long Leaf Park is one of the oldest and best known parks in New Hanover County. The park was given to the County in the 1920's. Located near the intersection of South College Road and Oleander Drive, the 98-Acre park is well known for festivals and events such as the Piney Woods Festival, the Sounds of Summer Concert Series, the Annual Chili Cook-Off, and the Wing Fling. Facilities include lighted tennis courts, playgrounds, ball fields with seasonal concessions, an equestrian ring and a Pet Exercise Area. The Winter Park Optimist Club operates the County's oldest youth baseball and softball program at the park. There are six picnic shelters, picnic tables, grills and rest rooms located in the park as well. The garden and gazebo near the pond area, are very popular places for weddings, especially in the Spring when the azaleas and dogwoods are in full bloom.

The Long Leaf Park has added a Nature Trail. Located behind the New Hanover County Senior Center on Shipyard Blvd., and directly across College Road from Long Leaf Park, the oldest public park in New Hanover County. The facility includes two trails; the inner trail, looping around a natural pond is .35 miles in length, the outer trail, looping the circumference of the property is .75 miles. An additional spur allows pedestrians to cross College Road to Long Leaf Park. The trail's location provides visitors to the Senior Center a convenient place to exercise. The trail features a beautiful stand of Cypress trees and magnificent Wild Magnolia specimens, Long Leaf Pine and a variety of native hardwood trees. A large area of native ferns highlight the center of the trail. The pond features a variety of aquatic plant life including turtles and water fowl. A footbridge graces the southeast corner of the pond. The habitat has been enhanced by a **Boy Scout** project which has provided wood duck and blue bird boxes in the area. Future plans include the addition of a gazebo, additional trail links and an outdoor environmental education center.

### **WRIGHTSVILLE BEACH MUNICIPAL PARK**

Wrightsville Beach Municipal Park, located just off Causeway Drive, provides a relaxed environment to enjoy a multitude of public facilities. The baseball field, picnic shelter and soccer field are only a few of the features the park includes. Volleyball pits, basketball and tennis courts, and restrooms are also available to the public. The popular and widely recognized John Nesbitt Loop surrounds most of the park in a 2.45 mile walkway that runs through the downtown area of the beach. The Fran Russ Recreation Center is a highlight of the park, providing a location for fitness classes and camps year-round, with all equipment provided. Certified fitness trainers teach classes each week ranging from Pilates and yoga to eight-week boot camps and specialized classes incorporating the Loop. A variety of lessons are also taught throughout the year, including tennis and shag lessons. An after-school program is even offered for children that attend Wrightsville Beach Elementary School.

### **HALYBURTON PARK**

Located at South 17th Street Extension (4099 17th Street), in the southwest district of the City, Halyburton Park is a 58-Acre tract of land comprised of gently rolling sandhills, wet pine flatwoods and limesink depressions, known as Carolina Bay Ponds. One pond holds water year round. After an extensive environmental review it was determined that the site is of regional significance due to the proliferation of natural features contained within the tract. Because the abundance of diverse, undisturbed plant collections in an urban area is so uncommon, the City, with support from both the public and environmental groups chose to maintain the site as a natural area with limited development. With this in mind, the City designed a park that emphasizes the property's natural areas, yet also provides light recreational facilities. The park has a handicap accessible 1.3-mile walking/bike trail, picnic shelter and playground area. You may call (910) 343-4750 for further information.

### **GREENFIELD LAKE PARK**

Greenfield Lake is a birding oasis within busy downtown Wilmington. The lake is within a city park and is fringed by mature cypress trees and a variety of mixed upland woods. A road (Lake Shore Drive) and paved walkway (approximately four miles long) surround most of the lake and provide easy access throughout the park-like setting. The parking lot at the end of Fourth Street is part of Greenfield Park. The 250-Acre park contains playgrounds, tennis courts, open space, shelters, skate-park, picnic tables, grills, concession stand, lighted facilities, passive area, multi-purpose trail, restrooms, water fountains, and a location for boat rentals. ### **JAMES E.L. WADE PARK**

The City's newest park, James E.L. Wade Park, was dedicated January 29, 2009. The 17-Acre park is located at 3500 Bethel Road and includes a 1/2 mile (10-foot wide) multi-use path, playground and open play area, picnic shelter, restrooms, and other amenities. The park is named for former Mayor and community activist, James E. L. Wade. For more information, call (910) 341-4604.

### **EMPIE PARK**

A 33-Acre park at 3300 Block of Park Avenue, Empie Park boasts a parking lot, restroom facilities, water fountains, playgrounds, all children's playground, tennis courts, open space, shelters, picnic areas, concession stand, basketball courts, athletic fields, lighted facilities, passive areas and the first functional off-leash dog park in Wilmington, **Wilmington Dog Park at Empie**. The park is incorporated into a 2-Acre site of unused land within the confines of Empie Park. Pet owners can release their dogs to run freely without fear of vehicles or lost animals. The loss of beaches for this purpose and the leash law has added to the demand for this facility. For more information call (910) 341-3237.

Recommendation to evacuate will be made by the New Hanover County Emergency Management Department. This recommendation will be broadcast over radio and television.

In the event you leave prior to the storm, it is recommended you turn off the water outside the house and turn off the main breaker in the electrical panel.

Fill out the attached Hurricane Preparedness form and the Special Assistance form, if applicable, and return it to the Landfall COA office.

The COA has set up a special group to respond to requests for information on property after the storm passes. Information cannot be secured until the storm passes, and the roads are cleared and drained. Homes and lots can only be inspected during daylight hours. All requests for information should be made to (910) 256-7604. The information service will begin to function no later than noon of the day after the storm passes.

Guests staying in Landfall after moving from their homes due to hurricane warning or damage should be registered on the attached form. Guests and residents are requested to stay in the home until roads can be cleared and drains re-opened. Numerous yards and road shoulders have been badly damaged by sightseeing motorists running around flooded roads. Minimizing traffic will speed clean up operations and reduce chances of personal injury. When guests leave, Security should be notified. Guests should be encouraged not to wait until the last minute as the gates will be closed when it is no longer safe for Security personnel to operate. After the hurricane has passed, guests should be discouraged from visiting until clean-up has been completed.

# Be RedCross Ready

## Hurricane Safety Checklist

Hurricanes are strong storms that cause life- and property-threatening hazards such as flooding, storm surge, high winds and tornadoes.

Preparation is the best protection against the dangers of a hurricane.

### Know the Difference

**Hurricane Watch**—Hurricane conditions are a threat within 48 hours. Review your hurricane plans, keep informed and be ready to act if a warning is issued.

**Hurricane Warning**—Hurricane conditions are expected within 36 hours. Complete your storm preparations and leave the area if directed to do so by authorities.

### What should I do?



- Listen to a NOAA Weather Radio for critical information from the National Weather Service (NWS).
- Check your disaster supplies and replace or restock as needed.
- Bring in anything that can be picked up by the wind (bicycles, lawn furniture).
- Close windows, doors and hurricane shutters. If you do not have hurricane shutters, close and board up all windows and doors with plywood.
- Turn the refrigerator and freezer to the coldest setting and keep them closed as much as possible so that food will last longer if the power goes out.
- Turn off propane tanks and unplug small appliances.
- Fill your car's gas tank.
- Talk with members of your household and create an evacuation plan. Planning and practicing your evacuation plan minimizes confusion and fear during the event.
- Learn about your community's hurricane response plan. Plan routes to local shelters, register family members with special medical needs as required and make plans for your pets to be cared for.
- Evacuate if advised by authorities. Be careful to avoid flooded roads and washed out bridges.
- Because standard homeowners insurance doesn't cover flooding, it's important to have protection from the floods associated with hurricanes, tropical storms, heavy rains and other conditions that impact the U.S. For more information on flood insurance, please visit the National Flood Insurance Program Web site at [www.FloodSmart.gov](http://www.FloodSmart.gov).

### What supplies do I need?



- Water—at least a 3-day supply; one gallon per person per day
- Food—at least a 3-day supply of non-perishable, easy-to-prepare food
- Flashlight
- Battery-powered or hand-crank radio (NOAA Weather Radio, if possible)
- Extra batteries
- First aid kit
- Medications (7-day supply) and medical items (hearing aids with extra batteries, glasses, contact lenses, syringes, cane)
- Multi-purpose tool
- Sanitation and personal hygiene items
- Copies of personal documents (medication list and pertinent medical information, proof of address, deed/lease to home, passports, birth certificates, insurance policies)
- Cell phone with chargers
- Family and emergency contact information
- Extra cash
- Emergency blanket
- Map(s) of the area
- Baby supplies (bottles, formula, baby food, diapers)
- Pet supplies (collar, leash, ID, food, carrier, bowl)
- Tools/supplies for securing your home
- Extra set of car keys and house keys
- Extra clothing, hat and sturdy shoes
- Rain gear
- Insect repellent and sunscreen
- Camera for photos of damage

### What do I do after a hurricane?



- Continue listening to a NOAA Weather Radio or the local news for the latest updates.
- Stay alert for extended rainfall and subsequent flooding even after the hurricane or tropical storm has ended.
- If you evacuated, return home only when officials say it is safe.
- Drive only if necessary and avoid flooded roads and washed-out bridges.
- Keep away from loose or dangling power lines and report them immediately to the power company.
- Stay out of any building that has water around it.
- Inspect your home for damage. Take pictures of damage, both of the building and its contents, for insurance purposes.
- Use flashlights in the dark. Do NOT use candles.
- Avoid drinking or preparing food with tap water until you are sure it's not contaminated.
- Check refrigerated food for spoilage. If in doubt, throw it out.
- Wear protective clothing and be cautious when cleaning up to avoid injury.
- Watch animals closely and keep them under your direct control.
- Use the telephone only for emergency calls.

### Let Your Family Know You're Safe

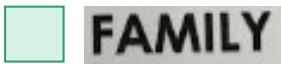
